Introduction

Bayer Healthcare is one of the ten largest speciality pharmaceutical companies in the world. We are UK and global leaders in women's health and manufacture or market a number of different forms of contraception including oral contraceptives, intrauterine system (IUS), non-surgical forms of sterilisation and an emergency hormonal contraceptive (EHC). This broad portfolio gives us an overarching view of trends in contraception and a perspective on how health policy can be shaped to reduce unintended, unwanted pregnancy and improve the sexual health of the nation.

We believe that access to high quality family planning is a human right and that every woman should be able to make an informed decision and choice about the most appropriate method of contraception for them, based on their preferences and how they wish to shape their life. Having access to the full range of contraceptives, including long acting reversible contraceptives (LARCs), is fundamental in making this a reality.

Since the passing of the Health and Social Care Act 2012 the responsibility to deliver public health services was passed to local authorities¹. This meant that the commissioning of sexual and reproductive health services was divided up between NHS England, clinical commissioning groups and local authorities.^{2,3} Local authorities have been given responsibility for large parts of commissioning contraceptive services, which are outside of the GP contract. Evidence has shown that dividing commissioning responsibilities across different bodies has led to fragmentation and also that some important parts of the programme, including the funding and provision of training for IUS/IUD fitters have not been defined clearly.

This report therefore looks at where contracts for the fitting of IUS/IUD are in place and the extent to which contracts include training and funding for training of healthcare professionals to fit IUS/IUD.

This work builds on a previous audit conducted by Bayer in the summer of 2013 (July – September) which set out to understand the range of elements in locally enhanced services (LES) for contraception.

The 2013 audit asked local authorities whether they had a contract in place for the provision of training for long acting reversible contraceptives (LARCs). Bayer's report on the findings – *The delivery of long acting reversible contraception in primary care: Findings from a Freedom of Information Audit*⁴ – showed that only 64 councils (46% of respondents) were able to clearly confirm that they did have such a contract in place⁵.

The delivery of long acting reversible contraception in primary care also looked at inter-practice referral pathways as a way of ensuring that women are able to access LARC methods even if there isn't a trained fitter at the practice they initially

present to. Only one in four (25%) of the local authorities which responded to the audit confirmed that they did have such an agreement in place⁶.

Key findings

- The majority of local authorities have contracts in place for the fitting of IUS/IUD with general practice (91%) and with contraception and sexual health (CaSH) clinics (97%)
- Of those local authorities who were able to provide details, all confirmed that contracts with general practice specify that healthcare professionals should meet national standards of training in order to fit IUD/IUS
- Where local authorities had contracts in place with CaSH clinics, 81% (116 out of 144) confirmed that the contract(s) specifies that the service provides training for healthcare professionals to fit IUS/Ds to national standards
- Two thirds of local authorities (66%) have a list of the practices and clinics that have trained IUS/IUD fitters
- Over half of local authorities (55%) do not monitor the number of trainers available to train healthcare professionals to fit IUS/IUD
- The majority of local authorities (56%) do not have arrangements in place to fund the training of healthcare professionals to fit IUS/IUD for the current financial year
- Only 58% of local authorities said that a referral pathway was included in the contract for women who wish to have an IUD/IUS fitted
- Two fifths (40%) of local authorities do not fund the unit cost of IUD/IUS. Instead, many local authorities have arrangements with the local clinical commissioning group (CCG) to reimburse the provider for the cost of the device
- More than half of local authorities (53%) do not fund IUS for non-contraceptive purposes

Recommendations

- **The Department of Health** should make clear to the commissioners and providers of contraception services where responsibility lies for funding and delivering training in fitting and removing IUS/IUD
- **Local authorities** should ensure that all service specifications and/or contracts stipulate that appropriate time and funding should be made available for training on fitting and removing IUS/IUD
- **Local authorities** should ensure that appropriate funding is made available for all aspects of IUS/IUD services, including the procurement of the device, training, fitting, monitoring and removal. Costs should be assessed over the full licensed lifecycle of the intervention
- **Local authorities** should, as part of their role as the commissioner of contraception services, take steps to critically assess workforce capability and capacity in fitting and removing IUS/IUD
- **Local education and training boards** should work with local authorities to ensure that there are sufficient numbers of trained healthcare professionals to meet local demand for IUS/IUD

Methodology

The contents of this report are based on the findings of a five part Freedom of Information (FOI) request that was sent to all upper-tier local authorities in England. The request was sent out on 18 December 2014 and responses were received up until 9 February 2015. In total, responses were received from 144 councils, representing a very encouraging response rate of 95%.

The FOI questions were limited to focus on the fitting of intrauterine devices (IUD) and intrauterine systems (IUS) and did not seek to collect information about the training for fitters for other types of LARC methods.

The questions in the FOI related to five related areas:

- Identifying where local authorities have contracts in place for the fitting of IUS/IUD and elements included in specification
- Uncovering whether records are kept of location of IUS/IUD providers
- Determining who is funding training
- Defining whether records are kept of HCPs qualified to train on fitting IUS/IUDs
- Determining the setting where most IUS and IUD fitting occurs

The requests made are listed in Annex 1 of this report.


Identifying where local authorities have contracts in place for the fitting of IUS/IUD

At the time of conducting this audit local authorities had been commissioning public health services for nearly two financial years. During this time, various different pieces of national guidance were issued to clarify where responsibility and accountability for the commissioning, provision and funding of contraception lies^{7, 8}. As outlined above, local authorities have responsibility for commissioning certain elements of sexual and reproductive health services including contraception (alongside the elements commissioned through the GP Contract).

As local authorities commission contraceptive services from general practice, local contraception and sexual health (CaSH) clinics and other service providers, this FOI audit aimed to gauge where contracts are held for the fitting of IUS/IUD.


Figure 1: Does the local authority hold contract(s) for the fitting of IUD/IUS with the following providers?

The majority of local authorities confirmed that they did have contracts in place for the fitting of IUS/IUD with general practice (91%) and with contraception and sexual health (CaSH) clinics (97%). Only 17% of local authorities also said that they had contracts with this provision in place with other local providers. This is set out in Figure 1.

The FOI audit then went on to ask about the percentage of GP practices and clinics in each local authority area where a contract is in place for IUS/IUD fitting. 108 local authorities were able to provide this information.

Figure 2 shows that there is a broad range of different percentages of GP practices and clinics that have signed up to a contract for the fitting of IUS/IUD. The lowest proportion of contracts are in place in Wigan Borough Council (18%) and three councils (Royal Borough of Kingston upon Thames Council, Rutland County Council and Solihull Metropolitan Borough Council) have 100% of GP practices and clinics signed up to a contract for the fitting of IUS/IUD.

Figure 2: Percentage of GP practices and clinics in each local authority area where a contract is in place for IUS/IUD fitting



The remainder of local authorities who responded to the FOI audit (36 out of 144) were unable to provide a clear response or said the information was unavailable. A number of local authorities cited that this information was not available because they currently in the process of negotiating contracts with general practice.

Other reasons cited by local authorities as to why this information was not available included that these contracts are held by the CCG or NHS England, or that a provider has an overarching contract and they sub-contract parts of the service with different parts of primary care.

"We do not hold the contract with practices directly but IUD/IUS fitting is included in the service specification and contract with provider organisation. The provider sub-contracts with primary care."

Local authorities were also asked to specify if any contract(s) for IUS/IUD fitting have been subcontracted to other settings in the local area (excluding general practice and CaSH clinics). Five local authorities stated that subcontracting has taken place. These local authorities were:

- Cornwall Council
- Essex County Council
- Royal Borough of Greenwich
- Kent County Council
- Leicester City Council

No specific details were provided about this subcontracting.

Training of fitters


Of those local authorities which were able to provide specific information about the number and percentage of contracts they have in place with general practice to fit IUS/IUD, 100% confirmed that contract(s) specify that healthcare professionals should meet national standards of training in order to fit IUD/IUS.

Examples of different types of national standards and guidance for training which were cited include:

- Royal College of Nursing accreditation
- The Faculty of Reproductive and Sexual Health accreditation
- Letters of Competence

Where local authorities had contracts in place with CaSH clinics, only 81% (116 out of 144) confirmed that the contract(s) specifies that the service provides training for healthcare professionals to fit IUS/Ds to national standards. A further 15% of local authorities (21 out of 144) stated that there was no such element to the contract with CaSH clinics.

Figure 3: Number of contracts with general practice and CaSH clinics which specify that healthcare professionals should meet national standards of training in order to fit IUD/IUS



Where CaSH clinics said that they did not have this element in their contract some of the reasons included:


- *"The contract asks that training is provided but does not stipulate national standards"* - **Bristol City Council**
- *"Not expected to provide the training"* - **London Borough of Hammersmith and Fulham Council**

- *"This is not specified in the contract. The training element is detailed in the service specification for this contract"* - **London Borough of Sutton**
- *"No, but we fund the CaSH service separately to provide training as required"* - **Waltham Forest Council**

Records of trained fitters

Local authorities were asked to confirm or deny if they keep a list of practices and clinics which employ staff trained to fit IUS/IUD. As set out in Figure 4, two thirds of local authorities (66%) stated that they did have a list of the practices and clinics which have trained IUS/IUD fitters.

Figure 4: Does the local authority hold a list of practices and clinics which employ staff trained to fit IUD/IUS in the local authority area?



Out of those local authorities which did not keep a list of practices with trained fitters, it was noted by some that they only kept a list of trained fitters where there is a contract in place. Therefore they do not have a comprehensive list of all of the services which have

trained fitters.

"We do not currently hold a list of staff. The responsibility is passed to the provider as part of the contract agreement and the contract arrangements are managed by the CSU."

Lancashire County Council

"The local authority holds a list of practices and clinics that provide the service. It is a condition of the contract that the provider employs suitably qualified and supervised staff, trained in delivering the service."


Reading Borough Council

A small number of local authorities stated that the responsibility for keeping a record of which practices and clinics have healthcare professionals trained to fit IUS/IUD has been passed elsewhere in the system. For example, Gateshead Council stated that they do not have such a list, but that First Contact Clinical⁹ manages this information. Lancashire County Council stated that the responsibility for holding a list of staff has been passed to the provider as part of the contract agreement.

Monitoring the levels of IUS/IUD Trainers

Local authorities were asked to confirm or deny whether they monitor the number of healthcare professionals qualified to deliver training in the fitting and removal of IUD/IUS in the local area. 63 out of 144 local authorities (44%) stated that they did monitor the number of trained IUS/IUD fitters. However, 79 out of 144 local authorities (55%) said that they did not monitor this. The full details are set out in Figure 5.

Figure 5: Does the local authority monitor the number of healthcare professionals qualified to deliver training in the fitting and removal of IUD/IUS in the local area?



For those local authorities which monitor levels of qualified IUS/IUD fitters, there were a range of different methods used to monitor this. These included:

- **London Borough of Bexley** – “We are starting to monitor the number of people qualified to deliver training through the regional training coordinator who is compiling a list of qualified personnel.”
- **Cambridgeshire County Council** – “The local Post Graduate Medical Centre monitors this training and keeps a database that contains details of training completed and when LoCs are required for each individual clinician. Practices must update the database before any contract can be awarded for the provision of IUD/IUS contraception.”
- **Dudley Metropolitan Borough Council** – “A database with fitter’s details is updated annually.”
- **London Borough of Harrow** – “Annual monitoring undertaken with submission of accredited certification from Faculty of Family Planning and Reproductive Health Care together with the number of procedures undertaken by individual practitioners.”


- **Middlesbrough Council** – *“Staff training numbers are supplied monthly in governance reports which are reviewed at the monthly contract review meetings.”*
- **South Tyneside Council** – *“Via a training co-ordinator based within a provider organisation.”*

Funding of training for fitters

The FOI audit questions went on to explore whether there are formal arrangements in place to fund the training of healthcare professionals to fit IUS/IUD. The question was asked in regard of the current financial year 2014/15 in order to understand where funding for training is coming from now and a subsequent question looked at how this might change in the next financial year.


Figure 6: Does the local authority has formal arrangements in place to fund training for healthcare professionals to fit IUD/IUS for 2014/15?

Figure 6 demonstrates that the majority of local authorities (80 out of 144 or 56%) do not have funding arrangements in place to fund the training of healthcare professionals to fit IUS/IUD for the current financial year. This is compared to 50 out of 144 local authorities (35%) confirming that they do have such funding arrangements in place.

Out of those 50 local authorities which confirmed that they do have a formal arrangement in place to fund training for healthcare professionals in the financial year 2014/15, 38 local authorities said that funding would still be available in 2015/16 as set out in Figure 7. Five local authorities which had funding in place for 2014/15 said that this would no longer be available in 2015/16. These local authorities were:

- Coventry City Council
- Devon County Council
- Gateshead Council
- Newham Council
- Plymouth City Council

This lack of certainty in relation to where responsibility lies for the funding of training of IUS/IUD fitters is worrying. The Public Health England document, *Making it work: A guide to the whole system commissioning for sexual health, reproductive health and HIV* states that:


“Ensure that training is supported for qualified professional to deliver services under all contracts, for example LARC fitting for contraceptive and non-contraceptive purposes in all relevant settings ... Commissioners should seek advice from the LETB about how they can support such training provision and work together to identify funding sources to meet training needs.”¹⁰

This lack of clarity about where funding for training will come from is a risk for the future of having an appropriately trained workforce.

Referral pathways in and from general practice

Another element of the contracting which was included in this FOI survey was information about whether referral pathways were included in contracts with general practice for women who wish to have an IUS/IUD if this is not available in the GP practice or clinic. As shown in Figure 8, 58% of local authorities said that a referral pathway was included in the contract. 28% of local authorities said that the contract did not include a referral pathway.

Figure 8: Does the contract include a referral pathway for women wishing to have an IUS/IUD fitted if it is not available in the practice/clinic where they first request or are prescribed this method of contraception?



Where local authorities did not have a referral pathway in place, there were a number of explanations including open access services in the area which women are able to self-refer in to.

"This contract does not include a referral pathway described above, as this contract is only signed by those practices who are able to offer this service" – **City of York Council**

Additionally, out of the 40 local authorities which said that they did not have a referral pathway in place in the contract with general practice 18 explicitly stated that this was because the contracts were only in place with providers able to deliver IUS/IUD fitting and therefore a referral pathway is unnecessary.


A number of local authorities stated that more practices may be contracted to provide these services by the local CCG.

Funding the unit cost of IUS/IUD in general practice

Since the commissioning of sexual and reproductive health services was divided between NHS England, clinical commissioning groups and local authorities, one of the key areas of confusion has been in relation to the payment for the unit cost of IUS/IUD.

In response to this FOI audit 70 out of 144 local authorities (49%) stated that they did fund the unit cost for IUS/IUD in general practice. 57 out of 144 local authorities (40%) did not fund the unit cost.

Figure 9: Does the contract with general practice include the funding of the unit cost for the IUS/IUD?



Out of those local authorities which did not provide the funding for the unit cost of IUS/IUD in contracts with general practice there were a number of different responses and explanations about how these unit costs are paid for, these included:

- *"This is not included in the contract, but the device recharged through prescription costs"* - **London Borough of Bexley**
- *"The contract includes a cost for the fitting and removal of the device is included in the service spec but not the actual unit cost of the device"* - **Buckinghamshire County Council**
- *"The current contract does not include reimbursement for the cost of the IUD/S unit, as this is currently recompensed via the CCG"* - **East Sussex County Council**
- *"The contract entitles practices to claim fees for fitting and also for removing devices. Practices are expected to purchase devices"* - **Manchester City Council**

- *"Funding does not currently cover the cost of the unit but this is under review to reflect recent Public Health England (Sept 2014) guidance 'Making it work: A guide to whole system commissioning for sexual health, reproductive health and HIV'" - Wigan Borough Council*

This continued confusion about who is responsible for paying for the unit costs of the IUS/IUD needs to be resolved swiftly. It is therefore welcome that Public Health England has now issued specific guidance stating that:


*"Local authority responsibilities - Contraception (including the costs of LARC devices and prescription or supply of other methods including condoms) and advice on preventing unintended pregnancy, in specialist services and those commissioned from primary care (GP and community pharmacy) under local public health contracts (such as arrangements formerly covered by LESs and NESs)."*¹¹

It is hoped that this guidance will help to clarify this funding situation and see local authorities putting in place contracts which ensure that funding for the unit costs flows correctly.

Funding of IUS for non-contraceptive purposes

A final question was included in the FOI audit to gauge whether local authorities have contracts in place with general practice to fund IUS for non-contraceptive purposes. 48 out of 144 local authorities (33%) stated that they do fund IUS for non-contraceptive purposes. However, more than half of local authorities (53%) stated that they do not fund IUS for non-contraceptive purposes.

Figure 10: Does the contract with general practice include the funding of IUS for non-contraceptive purposes?



Several local authorities who said they do not provide the funding of IUS/IUD for non-contraceptive purposes said that this is because it is a CCG responsibility:

- “No- IUS/ IUD fittings for non-contraceptive purposes is the commissioning responsibility of the Clinical Commissioning Group under the Health and Social Care Act 2012” – **Bedford Borough Council**
- “The contract does not include the funding of IUS for non-contraceptive purposes as it is not within remit of Public Health” – **East Riding of Yorkshire Council**
- “No, the funding for this contract is for contraceptive purpose only. As per national guidance, non-contraceptive purposes would be the remit of the CCG to commission as part of individual patient care” – **Salford City Council**

However, some local authorities said that they do not distinguish between reasons for fitting IUS/IUD, with others citing best practice guidance on managing heavy menstrual bleeding (menorrhagia):

- *“The contract is for implanting or removing IUS. The reasons for the use of an IUS are between the patient and the health practitioner”* – **Enfield Borough Council**
- *“Yes, as recommended by the Royal College of Obstetricians and Gynaecologists”* – **London Borough of Richmond upon Thames**
- *“Can also fit intrauterine devices for the purpose of management of menorrhagia – ensuring that devices are used in an appropriate manner and for correct patients and approved indications and in line with NICE Clinical Guideline CG44”* – **Wigan Borough Council**
